

TERMS OF PERSONAL DATA PROTECTION

Article I.

Introductory Provisions

The Controller shall be responsible for personal data processing under the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter the "GDPR")

The Controller adopted all appropriate technical and organizational measures to ensure personal data protection.

The Controller **does not appoint** any responsible person.

The Controller does not intend to transfer personal data to any third country or international organization.

"Personal Data" is any information related to identified or identifiable natural person (hereinafter the "Data Subject"); an identifiable natural person is a person that may be identified directly or indirectly, in particular with reference to the identifier such as a name, identification number, localisation data, on-line identifier or with reference to one or more elements that are specific to physical, physiological, genetic, mental, economic, cultural or social identity of such natural person.

Article III.

Rights of the Data Subject

Chapter 3 of GDPR stipulates the rights of the Data Subject.

If personal data is processed based on a written consent, the Data Subject may revoke their consent at any time. Revoking a consent shall not affect the lawfulness of processing resulting from a consent granted prior to its revoking.
